To the People of Oklahoma:

I am pleased to issue the April monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The U.S. Treasury yield curve continued its flattening trend in April. The 5-year Treasury closed the month at 1.68%, down .05% from April 1. The 10-year declined by .11% to close at 2.65% and the 30-year Treasury yield diminished by .15% to 3.46%. The difference between the five- and 30-year yields narrowed to 1.78%, with the difference being the tightest level since 2009.

The Dow Jones Industrial Average (DJIA) closed at a record level of 16,580 and gained .75% for the month. For January-April, the DJIA was up .03%. The S&P 500 closed at 1,883 with the benchmark index less than 10 points off its record closing level and for 2014 it had advanced 1.9%. The NASDAQ Composite finished at 4,114 which reflected a 2% loss for the month. NASDAQ was down 1.5% for April. The Federal Open Market Committee (FOMC) continued to proceed along its well telegraphed path and reduced its purchase of securities by another \$10 billion per month to \$45 billion starting in May. The FOMC maintained its commitment to the zero interest rate policy.

Economic Developments

The March unemployment rate was unchanged at 6.7%. U.S. employers added 192,000 non-farm jobs during the month, according to the Bureau of Labor Statistics. All of March's new jobs were attributed to the private sector as government payrolls were unchanged. The private service sector was the source of 167,000 of the month's job gains and reflected strength in professional/business services, restaurants, health care and retail.

The Conference Board's index of U.S. consumer confidence decreased slightly to 82.3 in April. The previous month's reading was revised to 83.9 from 82.3. The decline was the result of a weaker view of current conditions, with nearly one in three survey respondents reporting that jobs were "hard to get" while just 12.9% said that they were "plentiful". The Labor Department Consumer Price Index (CPI) increased by 0.2% in March and was 1.5% higher year-over-year. Surging food prices largely negated decreasing energy costs. Core CPI also rose by 0.2% for the month and showed a 1.7% year-over-year increase. The Bureau of Labor Statistics headline Producer Price Index (PPI) rose by 0.5% in March and by 1.4% year-over-year, while the core PPI rate increased by 0.6% during the month and 1.4% year-over-year.

The Commerce Department reported an advance in March retail sales by 1.1% which reflected the strongest reading since September 2012. February retail sales were also revised up from 0.3% to 0.7%. The Commerce report stated that consumers spent more at big-box stores, in restaurants and on the Internet. Outlays at building and gardening suppliers jumped 1.8% from February and sales at furniture stores increased 1%. The ISM-Manufacturing report climbed to 53.7 in March from 53.2 in February. The report showed that new orders grew 0.6% from the previous month and the production component had a substantial rise of 7.7%.

The National Association of Realtors (NAR) said that U.S. sales of existing homes fell 0.2% in March from the prior month to annual rate of 4.59 million units, which was the lowest level in over a year. The inventory of unsold homes supply was 5.2 months. The median sales price of \$198,500 was up 7.9% from a year earlier.

The Bureau of Economic Analysis' (BEA) advance estimate of first quarter 2014 real gross domestic product shows output produced in the U.S. grew at a slow rate of 0.1%. According to the BEA, the slow growth reflected a downturn in nonresidential fixed investment growth, as well as lower state and local government spending. The slim increase was attributed to a decrease in imports and an increase in personal consumption.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.82% in April and the weighted average maturity was 1,050 days. The year-to-date monthly average investable base was \$4.074 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 42% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 1% and Certificates of Deposit represented 2% of assets. Money market mutual funds and commercial paper sweep were 9%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,041,523,753 and State Agency balances in OK Invest at \$2,569,897,802 for a total of \$6,611,421,555.



In February 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2014. The amount estimated was \$68,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

April 30, 2014

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$6.72. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
