To the People of Oklahoma:

I am pleased to issue the October monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The Treasury market experienced volatility during October with large intraday swings. The 5-year Treasury had yields from a high of 1.72% and a low of 1.34%. The 10-year benchmark Treasury dropped from 2.44% to 2.14%, its lowest closing level since June 2013. The 30-year Treasury also exhibited some variability ending at 3.06%. The flight to quality will likely continue to push Treasury yields lower as investors shift funds away from riskier asset classes.

Stock markets rallied in the second half the month. The Dow Jones Industrial Average surged to 17,390 beating its previous record close set on September 19. In addition, the S&P 500 increased to 2,018, moving ahead of its prior closing record of 2,011. The Dow was up 4.9% for the year, and the S&P was up 9.2%. The NASDAQ closed at 4,630.

The Federal Open Market Committee eliminated its asset purchase program as anticipated, with no additional bond purchases beyond the reinvestment of principal payments. The Committee also left the federal funds rate target range unchanged at 0.0% to 0.25%, where it has been since December 2008.

Economic Developments

The Bureau of Labor Statistics reported the September unemployment rate decreased to a seasonally adjusted 5.9% from 6.1%. Non-farm payrolls were revised up by 38,000 to 180,000. Job gains were the highest in sectors such as professional/business services, retail, leisure/hospitality, health care/social assistance and construction.

The Consumer Price Index (CPI) increased in September to a seasonally adjusted 0.1% month-over-month, rising from -0.2% in August. Core CPI, ex-food and energy, was 1.7% higher on a year-over-year basis. The Producer Price Index tumbled by 0.1%, its first decrease since August 2013.

Retail sales for September dropped by 0.3% along with the core sales figures (excluding food, gasoline and building materials) which decreased by 0.2%. Sales decreased at auto dealers, furniture stores, building-supply outlets and clothing merchants. Automobile dealers' sales fell 0.8% after a 1.9% increase in August, which reflected a six-year high.

The National Association of Realtors reported that pending home sales increased 0.3% month-over-month, posting a positive gain for the first time in eleven months. The pending home sales under contract were up 1% from a year ago. Sales of previously owned homes were 5.17 million units, which was an increase of 2.4%. The initial third quarter Gross Domestic Product (GDP) advance reading was reported at 3.5%, down from 4.6% for the previous quarter. Consumer real personal consumption expenditures, the largest component of U.S. GDP, attributed to the quarterly growth and increased 1.8%. Durable goods comprised the majority of growth in personal consumption.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.79% in October and the weighted average maturity was 1,060 days. The year-to-date monthly average investable base was \$4.16 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 44% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 1% and Certificates of Deposit represented 3% of assets. Money market mutual funds and commercial paper sweep were 7%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 1%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,216,518,153 and State Agency balances in OK Invest at \$2,376,253,071 for a total of \$6,592,771,224.



In February 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2015. The amount estimated was \$73,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison October 31, 2014

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$1,628.75. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
